INDIA CHAIRS (PROFESSORS/ASSOCIATE PROFESSORS)

Applications are invited from eligible candidates for drawing a panel of Professors/Associate Professors on deputation as Visiting Indian Chairs on Long Term and Short Term assignment in various **universities abroad** in the following subjects in the Faculty of Humanities & Social Sciences: Hindi; Sanskrit; Urdu; Indian Philosophy; Gandhian/Peace Studies; Buddhist Studies; Political Science & International Relations; Economics; Modern Indian History; Contemporary Indian Studies; Indian Cinema/Film Studies; Financial Management; Innovation and Entrepreneurship and Indian Development Studies.

Essential Qualifications / Experience:

- The applicant should be an eminent academician having a Doctoral degree with proven academic and research credentials. He/she should have at least ten years of experience in post graduate teaching and / or post-doctoral research at a recognized university / national level institute including experience of guiding research at doctoral level.
- The incumbent should have at least 3 years service with his parent University/institution as on 31.05.2010. Prospective candidates should preferably be below age of 60 years.
- The deputation/assignment would be subject to the concurrence of the parent University/institution of the incumbent.

Terms and conditions of assignment/deputation:

● For Long-Term Chairs

- i) The tenure of deputation/assignment would be initially for one year and can be extended by mutual agreement to be executed by the candidates with the ICCR.
- ii) Basic pay+Grade Pay as being drawn at the time of deputation in parent department and Compensatory Foreign allowance as per IFS (PLCA) rules of Ministry of External Affairs or as determined by the ICCR.
- iii) Economy class airfare for self & spouse by ICCR and regular accommodation & medical facility/assistance will be provided by the host University during the foreign assignment.
- iv) Other terms and conditions would be as per the Memorandum of Understanding signed between the ICCR and the host university.

● For Short Term Chairs

- i) The tenure of deputation/assignment would be ranging from 3 to 6 months (one semester) initially and will be subject to the provisions of the agreement to be executed by the candidates with the ICCR.
- ii) Basic pay + Grade Pay as being drawn at the time of deputation in parent department and Compensatory Foreign allowance as per IFS (PLCA) rules of Ministry of External Affairs or as determined by the ICCR.
- iii) Economy class airfare for self by ICCR and fully furnished living accommodation and medical assistance will be provided by the host university during foreign assignment.
- iv) Other terms and conditions would be as per the Memorandum of Understanding signed between the ICCR and the host university.
